The purpose of this letter is to bring you up to date on our Steamboat trip, the FSA discounted lift ticket choices, and the Tampa pre-trip party.

Lift Ticket Information

On this day, FSA is required by the mountain to order these deeply discounted tickets. So, if your money is not **IN OUR HANDS**, be forewarned that you will be paying full price for your lift tickets (\$85/day) at the walk-up, wait-in-line windows.

Pre-Trip Party - Friday, January 18, 2008 – 6:30 p.m. to 9 p.m.

If you're a new skier/boarder, you will be able to obtain your permanent luggage tags at this party; otherwise they will be handed to you with your packet when we meet at the (Tampa) airport.
